OF SPECIAL SIGNIFICANCE ARE THE MUSEUM'S RENOWNED HOLDINGS OF MAJOR WORKS BY WILLIAM MERRITT CHASE AND FAIRFIELD PORTER. IT IS THE MUSEUM'S DESIRE TO CONTINUE TO COLLECT ALONG THIS LINE, AND WITHIN THE PAST SIX YEARS THE MUSEUM HAS DEVELOPED COLLECTIONS IN DEPTH OF THE WORK OF OTHER NOTEWORTHY ARTISTS SUCH AS ESTEBAN VICENTE AND ALAN SHIELDS. THE GOAL OF THIS STRATEGY IS TO ALLOW THE MUSEUM PERIODICALLY TO PRESENT FOCUSED INSTALLATIONS OF SELECT ARTISTS TO FOMENT DEEPER UNDERSTANDING AND APPRECIATION OF THOSE WHO HAVE MADE SIGNIFICANT CONTRIBUTIONS TO AMERICAN ART HISTORY AND WHO HAVE CLOSE TIES TO THE REGION. THIS DIRECTION IN COLLECTING SETS THE PARRISH APART FROM SISTER INSTITUTIONS THAT TAKE A MORE ENCYCLOPEDIAIC APPROACH THUS FURTHER CEMENTING THE MUSEUM'S SPECIAL NICHE WITHIN THE OVERALL LANDSCAPE OF MUSEUMS NATIONWIDE. SINCE 2012 THE MUSEUM HAS ADDED 341 WORKS TO THE PERMANENT COLLECTION AND MADE GREAT

HEADWAY IN REALIZING THIS GOAL. THE PERMANENT COLLECTION FORMS THE FOUNDATION FOR THE MUSEUM'S OVERALL EFFORTS. IN ADDITION, THE MUSEUM PRESENTED "ARTISTS CHOOSE ARTISTS," WHICH ENCOURAGES INTERGENERATIONAL COLLABORATION AMONG RECOGNIZED AND EMERGING ARTISTS AND FIVE OF THE FEATURED ARTISTS WORKED WITH MORE THAN 400 LOCAL CHILDREN AS PART OF AN ARTIST-IN-RESIDENCE PROGRAM HELD IN CONJUNCTION WITH THE EXHIBITION. THE MUSEUM PRESENTED TWO OFFSITE EXHIBITIONS IN THE LOCAL COMMUNITY AS A PART OF ITS SUMMER ROAD SHOW SERIES. THE MUSEUM'S PERMANENT COLLECTION WAS RE-INSTALLED FOR THE FIFTH TIME SINCE OPENING THE NEW BUILDING IN 2012. IN 2016 THE MUSEUM SERVICED AN AUDIENCE OF MORE THAN 60,000 CHILDREN AND ADULTS THROUGH ITS EXHIBITIONS, PUBLIC PROGRAMS, AND PARTNERSHIPS WITH LOCAL SCHOOLS.
