THE PARRISH ART MUSEUM, INC., IS LOCATED IN WATER MILL NEW YORK AND ACCREDITED BY THE AMERICAN ALLIANCE OF MUSEUMS. THE MUSEUM WAS FOUNDED IN 1897 BY SAMUAL LONGSTRETH PARRISH AND WAS CHARTERED BY THE UNIVERSITY OF THE STATE OF NEW YORK EDUCATION DEPARTMENT IN 1954. THE MUSEUM OPENED ITS NEW BUILDING DESIGNED BY HERZOG AND DE MEURON TO INTERNATIONAL ACCLAIM IN NOVEMBER 2012 ALLOWING IT TO EXHIBIT ITS PERMANENT ART COLLECTION SIDE-BY-SIDE WITH CHANGING EXHIBITIONS THROUGHOUT 12,000 SQUARE FEET OF GALLERY SPACE. IN 2018 THE MUSEUM ORGANIZED SEVERAL IMPORTANT EXHIBITIONS, INCLUDING "IMAGE BUILDING: HOW PHOTOGRAPHY TRANSFORMS ARCHITECTURE", "KEITH SONNIER: UNTIL TODAY" AND "PLATFORM: BARTHELEMY TOGUO". TWO PARRISH ROAD SHOWS HAVE ALSO BEEN PRESENTED, AS WELL AS THE 2018 STUDENT EXHIBITION, WHICH WORKS WITH SCHOOLS ON EASTERN LONG ISLAND'S ART TEACHERS AND ART CLUBS.
